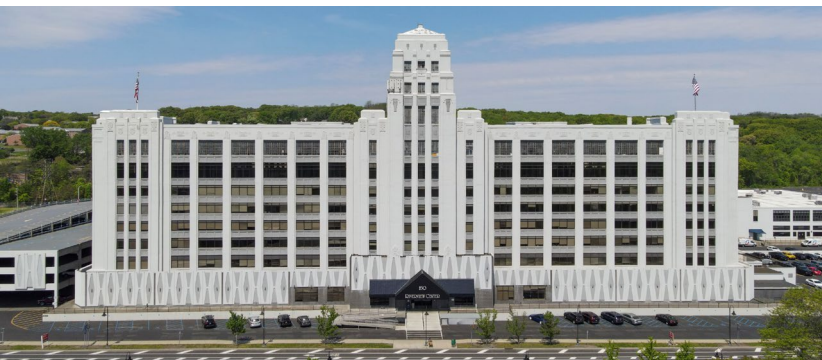
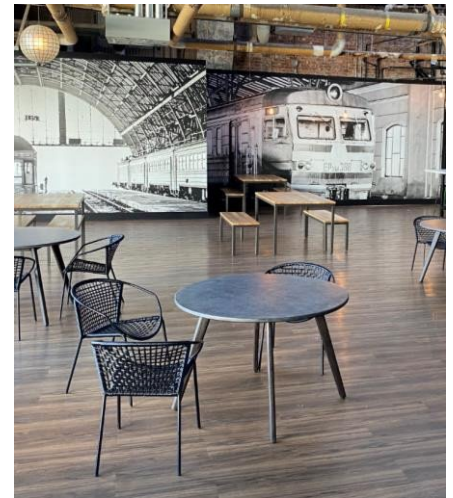
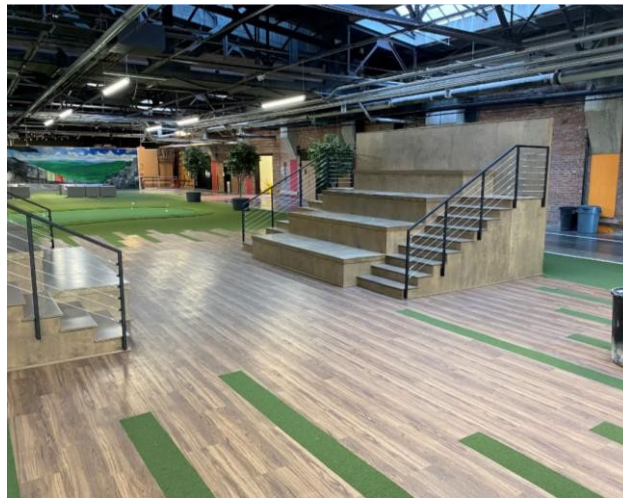
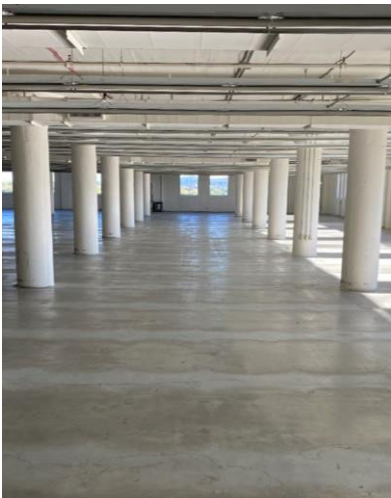
LOCATION MAPS
